

Job Description: Principal Adviser - Fire (Joint Inspection Team)

Reports to: Principal Fire Engineer

Directorate/team: Improvement /Joint Inspection Team, Fire Safety (JIT)

Grade: Grade 9

Job Purpose:

To provide the JIT Team with expertise in fire safety (theory, firefighting good practice, and legislation), that will be superior to landlords which may try to argue their unsafe buildings are compliant/ safe and advise at the inspections and give testimony at the enforcement stages.

Core Accountabilities:

- 1. Provide JIT with expertise in fire engineering and fire safety within a block
- 2. Provide evidence at Tribunals and Court cases the JIT supports local authorities on, and represent JIT at national policy making meetings
- 3. Maintain professional knowledge of all relevant legislation, systems, policies and professional best practice.
- 4. Contribute to the delivery of the team's agreed objectives.
- 5. Model the LGA's values and work in accordance with health and safety, equal opportunities and environmental policies.
- 6. Undertake any other duties and responsibilities appropriate to the post.

Specific Accountabilities:

- 1. Ensure the JIT team stays up-to-date of developments in fire safety good practice relating to residential high-rise buildings.
- 2. Help train non-fire engineer colleagues in the JIT, such as EHOs, Solicitor(s), and Intelligence Officers, and external staff.
- 3. Where necessary assist with drafting schedules of work, notices and orders for enforcement under Housing Act 2004, (where the 'host' local authority decides to take such action).
- 4. To be the lead fire safety expert for on-site inspections, and accompany teams of EHOs, and co-ordinate with building control manager and (where appropriate), 'host' borough staff on HHSRS site visits.

- 5. Contribute to HHSRS assessments of blocks, along with other professionals as part of Housing Act 2004 enforcement. The results of this assessment will then be passed to the local authority where the building is, so they can make a decision on any appropriate action.
- 6. Along with the JIT building controller, take the lead on advising on the scoping of remediation works required to make a block safe.
- 7. There will also be a requirement to train other JIT members in matters relating to Fire Safety to aid greater understanding, and attend some JIT team meetings, and undertake some training, (all time spent, and course fees paid for by the JIT).
- 8. Write witness statements, and attend court hearings as a witness.
- 9. As a key expert for the national JIT team, it will be expected that this post has some autonomy and leads for JIT on national meetings developing the new fire safety regulatory system.
- 10. Given the unsafe buildings are spread across England, it will be necessary to visit and stay overnight for a few days at a time in the normal course of the working week.
